DELIVERY AND TIMING

The shipping process and available options, including delivery method, are described during the purchase process. We reserve the right to use a substitute carrier for your purchase at any time, at our discretion. Further charges may occur if the order is larger than one case of wine (12 bottles). Delivery dates will depend on the carrier or our delivery schedule. If the Company is to deliver (Only within the lower mainland) The delivery schedule is as follows; Tuesdays – Surrey, Langley, White Rock; Wednesday – Aldergrove, Abbotsford, Agassiz, Chilliwack, Harrison, Hope (every second week); Thursday – Burnaby, Delta/Ladner/ Tsawwassen, New Westminster, North/West Vancouver, Richmond, Vancouver; Friday – Maple Ridge, Mission, Pitt Meadows, Tri-Cities. To make the delivery date, your order must be received before 6pm the night before. This time is provided as an estimate only, and the Company shall not be responsible in any manner for deliveries made outside of this time frame and reserve the right to deliver outside of this schedule as needed.
